The <u>Financial Report</u> for November 2021 was given by DeputyTreasurer Lovelace as follows: The General Fund balance brought forward was \$142,961.93, with receipts of \$17,875.73, less disbursements of \$5,660.89, leaves a balance in the General Fund of \$155,176.77 plus CD's of \$20,000.00 (\$10,000.00 being Stabilization CD) leaves an overall balance in the General Fund of \$175,176.77. The Road MIF balance brought forward was \$46,199.16, with receipts of \$7.85, less disbursements of \$0.00, leaves a balance in the Road MIF of \$46,207.01 plus CD's of \$20,000.00 leaves an overall balance in the Road MIF of \$66,207.01. The Fire MIF balance brought forward was \$39,782.83, with receipts of \$6.46, leaves a balance in the Fire MIF of \$39,789.29, with disbursements of \$0.00, leaves a balance of \$, plus a CD in the amount of \$10,000.00, leaving an overall balance in the Fire Fund of \$49,789.29. <u>Planning Commission:</u> Carrie Mullins was present and made comments regarding the last Planning Commission meeting of 2021. The 2022 Planning Commission meeting schedule was presented to the board. Meetings will be held the Wednesday prior to the Board meetings at 6:00pm.

<u>Roads & Bridges:</u> Supervisor Corn shared that Kent Power Inc is renting the property at 2214 S. Barlow Road to stage their equipment and employee vehicles during a project for the price of \$400.00. Supervisor Corn has been discussing the request to change a portion of London Rd from a seasonal road to a regular county road. They have the paperwork. Supervisor Corn inquired about gravel for some of the seasonal roads. The Road Commission is 2 years behind in the ditching at this time.

<u>Fire Department:</u> Fire Chief Regina Waskiewicz was present and gave report for November. Total calls were seventeen (17); Mikado Twp. zero (0) fires and eleven (11) medical; Gustin Township zero (0) fires and four (4) medical. Mutual Aid fires: Two (2) mutual aid fires, zero Personal Injury Accidents and zero search/rescue were also reported. Updates: All radios are here and in service. Batteries have been installed in 5-1 New Business: Department Christmas gathering will be Wednesday December 15, at 7:00pm at the Fire Hall. Pot luck style, all board members are invited to join us.
