The Road MIF balance brought forward was **\$38,330.41**, with receipts of **\$6.51**, less disbursements of \$0.00, leaves a balance in the Road MIF of **\$38,336.92** plus CD's of **\$20,000.00** leaves an overall balance in the Road MIF of **\$58,336.92**. The Fire MIF balance brought forward was **\$39,810.07**, with receipts of **\$6.76**, leaves a balance in the Fire MIF of **\$39,816.83**, with disbursements of \$0.00, leaves a balance of \$, plus a CD in the amount of **\$10,000.00**, leaving an overall balance in the Fire Fund of **\$49,816.83**. <u>Fire Department:</u> Fire Chief Regina Waskiewicz was present and gave report for February. Total calls were nineteen (9); Mikado Twp. zero fires and seven (7) medical; Gustin Township one (1) fires and one (1) medical. Mutual Aid fires: zero (0) mutual aid fires, zero Personal Injury Accidents and zero search/rescue were also reported. Updates: Received part of the insurance claim, new pagers arrived and are in use. Fire Chief reports that there are several firefighters that have, per the bylaws, are due for dismissal from the fire department due to lack of participation and training. She will be sending them registered letters and they must return their gear within 14 days. The fire department is gearing up for spring fire season which is anticipated to be begin early due to the lack of snow.

<u>Ordinance Enforcement Officer</u>: Officer Waskiewicz reported no new land use permits were requested for February 2022.
