Minutes of Mikado Township Board Meeting May 9, 2022

The <u>Financial Report</u> for April 2022 was given by Treasurer Travis as follows: The General Fund balance brought forward was \$182,261.93, with receipts of \$5,906.06, less disbursements of \$6,503.93 leaves a balance in the General Fund of \$181,664.06 plus CD's of \$20,000.00 (\$10,000.00 being Stabilization CD) leaves an overall balance in the General Fund of \$201,664.06. The Road MIF balance brought forward was \$93,010.97, with receipts of \$8,038.25, less disbursements of \$0.00, leaves a balance in the Road MIF of \$101,049.22 plus CD's of \$20,000.00 leaves an overall balance in the Road MIF of \$121,049.22. The Fire MIF balance brought forward was \$52,034.63, with receipts of \$4,028.25, leaves a balance in the Fire MIF of \$56,062.88, with disbursements of \$0.00, leaves a balance of \$56,062.88, plus a CD in the amount of \$10,000.00, leaving an overall balance in the Fire Fund of \$66,062.88.
