

Minutes of Mikado Township Board Meeting
July 11, 2022

Supervisor Michael Corn called the Mikado Township Board Meeting to Order at 7:02pm. He welcomed the guests that were present and joined in the Pledge of Allegiance.

Roll Call showed Supervisor Corn, Treasurer Travis, Trustee Mullins and Trustee Nedo were present

The Financial Report for **June 2022** was given by Treasurer Travis as follows: The General Fund balance brought forward was **\$184,747.13**, with receipts of **\$7,040.69**, less disbursements of **\$12,016.74** leaves a balance in the General Fund of **\$189,771.08** plus CD's of **\$20,000.00** (\$10,000.00 being Stabilization CD) leaves an overall balance in the General Fund of **\$209,771.08**. The Road MIF balance brought forward was **\$104,710.33**, with receipts of **\$1,570.64**, less disbursements of \$0.00, leaves a balance in the Road MIF of **\$103,139.69** plus CD's of **\$20,000.00** leaves an overall balance in the Road MIF of **\$126,280.97**. The Fire MIF balance brought forward was **\$56,072.01**, with receipts of **\$9.13**, leaves a balance in the Fire MIF of **\$58,081.14**, with disbursements of **\$0.00**, leaves a balance of **\$56,072.01**, plus a CD in the amount of **\$10,000.00**, leaving an overall balance in the Fire Fund of **\$66,081.14**.
